MEMBERSHIP AGREEMENT

I agree that upon application to the Barefoot Bay Golf Course ("BBGC), a valid and binding contract between Barefoot Bay Recreation District ("BBRD") and the applicant/member of the BBGC further agree to be bound by rules, regulations, and policies of the BBGC now or hereinafter in force.

I agree to abide by Florida Beverage laws and license regulations pertaining to Alcohol Beverage Control. I understand, bringing alcoholic beverages to District facilities is prohibited. Where permitted, all alcoholic beverage purchases must be provided by the Barefoot Bay Recreation District. BBRD Policy Manual General Rules p. 23.

It is understood that I incur no liability for any of the debts or obligations of the BBGC, or or the BBRD and that I have no interest whatever in any of the assets of the BBRD except such rights and privileges as are granted by the ownership of my Golf Membership.

The applicant acknowledges liability for payment of all dues incurred by the undersigned applicant, his or her family or any guests of applicant or his or her family.

Should the BBRD hire an attorney to enforce its rights under this agreement and / or to collect any outstanding financial obligation arising from this agreement, I understand that I will be liable to pay reasonable attorney's fees and costs to the BBRD whether suit be brought or not.

I understand my Golf Membership may be terminated for breach of this agreement and / or as set forth in the rules and regulations of the BBGC.

The above mentioned rules, regulations and policies as may be revised from time to time, are incorporated herein by reference.

It is further understood that this Golf Membership is NOT transferable..

It is further understood that any Medical disabilities that arise during the fiscal year must be documented in writing by the applicants <u>physician only</u> through March 31st of the fiscal year of the Golf Membership in order to receive a pro-rated refund. BBRD Policy Manual p.27

This agreement is valid from the date of signature and will automatically renew unless the Golf Course member requests to terminate this agreement.
